Basically, I am trying to serve PDF files while obscuring the actual file path of the PDF. That is, I want to save the PDF in a non-public accessible directory, but when an authorized user requests the PDF, I want to verify they're authorized and if so, serve the PDF.

The framework is setup. We have two users with distinct roles able to login to the web application. At this point, running the application allows both users to access the PDF file. This is because Visual Studio's web server considers any non-application file to be a simple static file. Just like a GIF or JPG, the PDF file may be accessed by any user.
